#### **SPOKANE CONFERENCE CONTINUED**

For those who want to take individual sessions, because of the costs involved in organizing these conferences, we need to change the rate to \$50 per session with a minimum of two sessions per day.

#### THE IMPORTANCE OF SAVING EXPLANATIONS OF BENEFITS (EOB'S)

It seems that our low-income clients always end up at the short end of the stick when there are changes to laws that affect medical care. Not long ago, it was that Medicare would pay for an ambulance to the emergency room but not home, even for clients with severe dementia. In order to appeal, which we at Bridge Builders, Ltd. did successfully a number of times, EOBs for the date of service are needed. Somehow things have adjusted and we haven't had to appeal for this situation for a while.

Now with the change in the laws regarding Opioids, doctors are prescribing over-the-counter (OTC) remedies instead of going directly to a controlled substance. For this I laude the new law because many times the OTC remedies work well and they don't have the risk of falls and other problems that the controlled substances have. However, when a client is on Medicaid, OTC medications are not automatically paid. Until recently, we didn't have too much trouble with this as we would fax DSHS the prescription from the doctor and the documentation from the Medicare Part D plan showing that the Medicare Part D plan denied it. We would appeal and that would be denied and we would include these and DSHS would make an adjustment in participation in order to accommodate the cost of the OTC. But this didn't work recently. When we asked we were told that according to the WAC 182-513-1350 they did not have verification that the drug prescribed was medically necessary (they assume that the doctor prescribed it just for giggles?) and they needed notice that an appeal had been filed with Medicare to have this prescription covered.

When we questioned this we were told that a letter from the doctor was necessary saying that the medication was medically necessary (again, the doctor prescribed it just for giggles?). We said that we had submitted the appeal to Medicare Part D, but were told that we needed to submit an appeal to regular Medicare even though our client was not in a skilled nursing facility. Again, in order to do the appeal, one needs the EOB.

Fortunately, we scan all EOBs into the computer labeled by date so that we (or more likely, my wonderful bookkeeper) can find what we need fairly easily. But, good grief!, this OTC medication was far less expensive than the Opioid and without the side-effect of becoming a fall risk. And then there is the fact that we as guardian for this pro bono client get paid nothing for the additional work required so that our client doesn't get less for personal needs.

This is not the fault of the DSHS financial people. It is the crazy way our government does things. And, yes, I know that I'm ranting about the System but what about the EOBs? Well, we guardians need to keep those EOBs and file them in a way that is meaningful to each of us. If a guardian throws these away, then when an appeal is needed, it requires much, much more work. Scanning is the way to go, if you ask me. Not the slow flatbed scanners but the feeder scanners like ScanSnap. They are on the expensive side but they can save hours upon hours of time on the long run.

Hours: Part-time, as needed, approximately 10-20 hours per week. (1-3 days of work per week)

Compensation: DOQ, \$30 per hour; mileage reimbursed at 0.545 cent per mile.

**Essential Job Responsibilities** 

• Conduct initial, and quarterly visits with assigned clients of the agency (unless an alternate visitation schedule is established by court order)

• Confer with the Incapacitated Person, family members, and healthcare professionals, as appropriate.

• Prepare meaningful in-person visit reports addressing changes or concerns in the general health and welfare of clients.

• Prepare and maintain a record of all work-related activities and contacts performed on behalf of the individual, submits this information to the Agency Director within 24 hours of provision of services.

• Other duties as assigned.

Required Knowledge, Skills and Abilities

- Comfortable asserting self in role of advocate
- Work compassionately with difficult clients and situations
- Must have a working knowledge of community resources
- Must have reliable transportation to locations that may or may not be located on public transportation lines to provide services to individuals in the community

• Ability to maintain strict confidentiality of client information.

**Qualification Standards** 

- Must hold an active Certified Professional Guardian (CPG) designation in Washington state
- Bachelor's degree preferred in health and human services, nursing, or related discipline

• At least 1 year experience serving individuals with developmental disability, mental illness, or the elderly.

• Additional experience in fields of long term care, dementia and related illnesses, substance abuse, traumatic brain injury, and related available services desirable

#### **ASSISTANCE RECIPIENTS**

#### Client A0004—Skagit County

Mini-grant awarded: \$2,400.00

#### Amount Expended: \$900.00

Client A0004 is 23 years old with cognitive and medical conditions and not a US citizen. She currently lives in an Adult Family Home. The guardianship is funded through the Public Guardianship Program. She currently does not qualify for SSI or DDA services because she is not a US citizen. The guardian is working with an immigration attorney with the goal of getting her citizenship. She can work but needs a job coach and the job coach funding ran out. The Guardian Institute has approved a \$2,400.00 grant that will cover one-month of job coaching. While the guardian will try to recruit volunteers to help defray the cost but depending on the job she gets, this may or may not be possible. This client needs to be able to work at least until she can qualify for SSI or DDA or both. *There has been some delay in starting the job coaching. The CPG has negotiated a lower hourly rate. If for some reason this plan cannot be implemented, the GI Board has approved using the funds for other needs the client might have.* 

Additional donations are needed for continued job coaching.

#### CLALLAM COUNTY IS LOOKING FOR VOLUNTEER GUARDIAN ADVOCATES

*We have our first volunteer!* Now, we're working on figuring out how to connect a potential guardian with an incapacitated individual in need of a guardian. Several people are working on this conundrum.

There is a great need for guardians for our most vulnerable population. The Guardian Institute is looking for volunteers for the Volunteer Guardian Advocate pilot program, starting immediately. The time requirement is an average of five (5) hours each month and each volunteer is asked to commit for 3-years with optional renewal. A Volunteer Guardian Advocate is NOT a caregiver. A Volunteer Guardian Advocate is to advocate for their client's needs and appropriate wants, ensure the client is getting the benefit of all the resources he/she qualified for, assist the client with making medical decisions or make medical decisions on the client's behalf if the client cannot do so.

#### **Basic Requirements:**

- Be at least 18 years old
- Be of sound mind
- Have no felony convictions
- Have no misdemeanor convictions involving moral turpitude
- Be a resident of Washington State
- Have completed mandatory (online) training
- Be a person who the court finds suitable
- Commitment renewal every 3-years
- Average time needed is 5-hours monthly
- 1-2 guardianship limit per volunteer

#### The Guardian Institute will provide:

- Arrange legal assistance as needed
- In-person training
- Provide a mentor as needed
- Assistance with Standby Guardian requirement

When he is not at work or camping in the mountains, Judge Naught and his wife travel the Pacific Northwest in support of their three children who play on three different soccer teams.

Steve wants to show that he is not the monster society at large may fear, but rather has a brain disorder that "goofs him up" on occasion. He takes his medications religiously and has recovered, as do any individuals with mental illness folks. A snapshot of Steve before his first mental health crisis is immaterial. In the past 18 years he has been named the Washington State Behavioral Health Conference Employee of the Year for his work as a Peer Specialist, published a first person account in the American Psychiatric Association Journal of Psychiatry, and given numerous talks in Spokane on his story of recovery. Steve credits faith in Jesus Christ as the lynchpin to his ongoing success.

**COMMISSIONER RACHELLE ANDERSON**, Superior Court was appointed to the court in 2010. Prior to that she was an Administrative Law Judge for the Washington State Office of Administrative Hearings following 13 years in private practice, emphasizing Family Law and Juvenile Dependency work. Ms. Anderson received her undergraduate degree from Eastern Washington University and her Juris Doctorate from Gonzaga University School of Law.
